**Kuala Lumpur, 5 March 2021** - Wong & Partners advised ib vogt GmbH (ib vogt) on its successful bid for and development of a solar photovoltaic power plant in Marang, Terengganu, under Malaysia's third large-scale solar tender project ("**LSS3**"). Our representation began at the bidding stage, on to the project development phase and the project financing phase.

We represented ib vogt GmbH (ib vogt), a German-based multinational integrated photovoltaic development company, in connection with its successful bid to develop a 100MWac (Mega Watts, alternating current) solar photovoltaic power plant in Marang, Terengganu, under Malaysia's third large-scale solar tender project ("LSS3"). This was a significant win for our client and their Malaysian consortium partner Coara Solar Sdn Bhd, as they became one of just five successful bidders, of the tender which [was heavily oversubscribed with a reported 112 bids](#).

We continued to advise ib vogt and Coara Solar Sdn Bhd in connection with the project development of a 116MWp solar photovoltaic ("PV") farm in Marang, Terengganu ("Project"). We assisted the client in the drafting, reviewing and finalization of the joint venture agreement and relevant project documents, including the lease agreement, power purchase agreement ("PPA"), EPC Contract, O&M Contract and project development agreement.

As the project progressed, we represented Coara Marang Sdn Bhd, the special purpose vehicle set up by ib vogt and Coara Solar Sdn Bhd to undertake the Project, in connection with the term loan facility and bank guarantee facility granted by Malayan Banking Berhad.
