Please be aware of scams and impersonation attempts

Kuala Lumpur - Wong & Partners, member firm of Baker McKenzie International, has been alerted to various scams involving individuals impersonating representatives of the Firm and misusing Firm information.

These scams include the offering of fake legal services for recovery against victims of scams; legal summonses and communications; the unauthorised use of the Wong & Partners and Baker McKenzie logos; fake Firm social media pages, and fraudulent job postings—often using Gmail addresses and platforms like Telegram, Instagram and Facebook, to obtain private and confidential information.

Wong & Partners will not:

1. Send legal documents, undertake any form of legal services or communicate job vacancies via Facebook, Instagram, Gmail, or any other unofficial channels.
2. Make contact via social media platforms to offer legal services, including recovery services.
3. Request payment to an individual's account.
4. Authorise third parties to engage in these services on our behalf.

If you receive a Facebook or Instagram message offering our legal services, emails from Gmail or non-Firm email addresses claiming to represent us, do not respond, share personal information, or click any links. Please note that our Firm only uses official email domains.

Please also be aware of fake social media profiles on platforms such as Facebook and Instagram [please see below for a list of our official social media channels].

If you receive any suspicious communication with our logo, Firm information or from people claiming to be a Firm representative, and wish to verify the information, please contact us on our telephone line + 603 2298 7888. You are advised not to share any personal information before doing so.
